1. Appointment of Chair and Vice Chair

Cllr Len Scoullar appointed as Chair. Cllr Ellen McMaster appointed as Vice Chair.

2. Minute of Meetings held on 12 December and 5 December 2018

The Minutes were agreed as an accurate account of both meetings.

Action – It was agreed to move to minuting in the form of an Action note for the FSG from this meeting onwards.

3. Matters Arising

Robert Morrison updated that CFL have discussed with the contractor a move to reporting against timetable not contractual but this has been confirmed not to be possible.

4. VRDP Update by Transport Scotland

Paul Flynn presented the draft VRDP Annual Report for 2018 (which includes 2017 update).

Action – Members will submit written comments on the draft VRDP to Transport Scotland by Friday 21 June 2019

Action – Transport Scotland will seek to make more accurate reporting of vessel utilisation to properly understand the impact of freight carriage on the vessel capacity. This would see future VRDP reporting taking cognisance of the impact of a full vessel deadweight leading to a limited carrying capacity even meaning the vessel needs to sail with space on the vehicle deck.

5. Operational and Performance Update

CalMac Ferries Limited

Demi Wylie presented on Winter 2020/21 timetable change consultation.

Andrew McNair presented a marketing and commercial update.

Simon Richmond provided the update on operational reporting.

Action – Demi Wylie would send the form for timetable change suggestions to Campbeltown Ferry Committee and ensure they are not missed in future calls for changes. Action – CFL are keen to work with DMOs and others on collaborative marketing and would invite proposals from all stakeholders if they identify an opportunity.

Action – It was agreed that the Secretariat would prepare a letter from the Clyde, Kintyre and Islands FSG to be sent to the Minister for Energy, Connectivity and Islands on the critical need to find funding to support the delivery of a vessel upgrade programme estimated to extend to 6 major ferries and 4 non-major vessels.

8. Masters Decision Making – Presentation

Robbie Drummond presented this item alongside Mark Thomson. The presentation covered the process that is followed by Masters on decision taking around the operation of sailings and the legal liabilities that each Master must carry.

Action – Transport Scotland to update the FSG on the outcome of the Communities Board proposal to reduce charging of school minibuses to the rate levied on equivalent sized motorhomes.
