Active Travel Update

SUMMARY:

To provide Members with an update on active travel work supported by HITRANS

Scottish Government Programme for Government: Active Travel Funding:

The Scottish Government, through their Programme for Scotland 2017-18 announced that the annual investment in walking and cycling will double to £80M from 2018-19. This includes funding for Low Emission Zones in Scotland four largest cities. Below is an extract from the detailed Programme;

"We will build an Active Nation, boosting investment in walking and cycling and putting active travel at the heart of our transport planning. Our actions will include:

- making our towns and cities friendlier and safer spaces for pedestrians and cyclists by increasing investment that supports active travel from £40 million to £80 million per year from 2018-19
- appointing an Active Nation Commissioner to ensure delivery of world-class active travel infrastructure across Scotland
- stepping up promotion of the use of electric bicycles to ensure as many people as possible can benefit from active travel
- delivering projects which help older people benefit from our network of walking and cycling routes

We will work towards delivering a long distance walking and cycling route, offering an experience equivalent to the successful North Coast 500 and continue our investment for walkers, cyclists and equestrians on the A9 corridor, including 35 km of new cycle track to connect the A9 route with the wider National Cycle Network."

HITRANS Community Links Application: Inverness Railway Station Active Travel Improvements.

As previously reported, HITRANS have been successful in receiving £75,000 in funding towards feasibility, community consultation and outline design for active travel routes linking into the three pedestrian entrances to Inverness Railway Station. This work seeks to provide additional improvements to the ongoing work led by Abellio ScotRail and The Highland Council that will help ensure the walking and cycling infrastructure providing access to and from the station is enhanced to better meet the needs of the local users and businesses. This contract has been awarded to Civic Engineers, in partnership with Optimised Environments and Doig+Smith. The inception meeting is taking place 12th September.

Community Links PLUS:

HITRANS have supported The Highland Council in their Community Links PLUS application for the 'Inverness City Active Travel Network'. This project has for the second year reached the final stage of the design competition, and HITRANS Active Travel Officer joined The Highland Council team presenting their application to the competition panel. If successful this project would see Inverness aim to increase its cycle to work figures from 5.5% to 11%, and would see significant infrastructure changes throughout the town centre, and along the 'east to west' corridor, to promote walking and cycling, and links to key destinations.

Other Active Travel projects:

- Cordon counts: HITRANS have been working with Highland and Moray to deliver active travel/full traffic cordon counts as required in Inverness, Elgin and Forres to help gain baseline data for active travel, and to help prioritise active travel interventions. Going forward we are keen to carry out more surveys within other audit towns and will liaise with partners to assess interest.
- Maps: We are continuing to work with our partners to deliver active travel maps. In particular we are working to deliver maps for Stornoway, Aviemore, Elgin and Fort William at present, and will progress to other locations as required.
- Green CHIPS: HITRANS have been approached by contacts within NHS Highland to
 provide funding for a pilot e-trike to enable patients to be cycled from doctors
 surgeries to other healthcare settings for treatments in Inverness. The first
 engagement will be with Cairn Medical Practice but several other surgeries are also
 keen to be involved. This work links into the active health project being taken forward
 at the Inverness Campus and the active travel officer will report back on learning for
 other settings in the region.
- Urban Design Framework: HITRANS are working along with Orkney Islands Council officers to help deliver their UDF, in particular looking to update aspects of the Kirkwall active travel audit, and learning from their previous Smarter Choices Smarter Places 'Kickstart Kirkwall' project.
- National Cycle Network Route No.78: Work on the section of the NCN78 between Onich and Corran ferry is progressing well, with only the bridge over the Righ burn still to be installed. South of Ballachulish, Sustrans are working with the NCN steering group and Argyll and Bute Council to look at options for the two 'gaps' within the NCN78 route.
