# **Regional Transport Strategy Update**

# **Purpose of Report**

To invite Members to consider a proposal to update the HITRANS Regional Transport Strategy.

#### **Background**

HITRANS original Regional Transport Strategy was approved by Scottish Ministers in July 2008. During 2016 / 2017 HITRANS consulted initially on a Main Issues Report and then published a draft updated Strategy in May 2017. Following further statutory public consultation, a final version of the Strategy was approved by Members at the HITRANS Partnership Meeting in September 2017. However, on seeking Ministerial approval for the updated Strategy, officers were advised that any approval would not be forthcoming until after the National Transport Strategy itself had been updated.

The National Transport Strategy 2 was published in February 2020 setting out the vision for Scotland's transport system for the next 20 years. The vision is underpinned by four priorities: Reduces Inequalities, Takes Climate Action, Helps Deliver Inclusive Economic Growth and Improves our Health and Wellbeing, each with three associated outcomes.

#### HITRANS updated Regional Transport Strategy

HITRANS updated Regional Transport Strategy, sets out a vision to deliver connectivity across the region which enables sustainable economic growth and helps communities to actively participate in economic and social activities.

The RTS objectives were also updated as set out below. They were underpinned by two high level objectives which were to;

- Support sustainable economic growth across the whole region
- Reduce barriers to participation in employment, learning, social, leisure, health and cultural activities throughout the region

reduce barriers to participation in employment, learning, social, leisure, health and cultural activities through the region

# National Transport Strategy 2 & Strategic Transport Projects Review 2

The Scottish Government published a new National Transport Strategy in February 2020 with a vision supported by four priorities: reducing inequalities; taking climate action; helping deliver inclusive economic growth; and improving health and wellbeing. The strategy outlines the Scottish Government response to the Climate emergency, committing Scotland to an ambitious statutory target of net-zero greenhouse gas emissions by 2045.

Central to our update of the RTS will be outlining how we intend to address regional challenges and opportunities for transport within our area whilst realising the Scottish Governments

Overarching the policies, the Sustainable Travel and Investment Hierarchy which prioritises the most sustainable modes and utilisation of existing assets has been imbedded into the decision making process.

#### **Our Vision**

We will have a sustainable, inclusive, safe and accessible transport system, helping deliver a healthier, fairer and more prosperous Scotland for communities, businesses and visitors.

- Will be easy to use for all
- Will be affordable for all



# **Takes climate action**

- Will help deliver our net-zero target
- Will adapt to the effects of climate change

#### Other new Local and National Policy and Strategy

In addition to NTS2 and STPR2, there are several other documents published at both a local and national level which have a material impact on both the context and priorities of the Regional Transport Strategy.

#### These include the following;

- Islands (Scotland) Act 2018 and National Islands Plan The updated RTS included an island proofing review of the Delivery Strategy but was published prior to the first National Islands Plan in 2019.
- Transport (Scotland) Act 2019
- Climate Change Plan Update, December 2020 and National Transport Strategy Delivery Plans, including commitments to undertake Island Connectivity Plans and a national Aviation Strategy
- National Planning Framework 4
- A number of key Local transport and planning documents including the updated CNES Local Transport Strategy and several Local Development Plans

## **Impact of Covid-19**

While it is much too early to consider what even some of the short to medium term impacts of the Covid-19 pandemic will be, updating the strategy at this time offers an opportunity to establish regional priorities for securing a green recovery on a path to net zero.

## **Regional Transport Strategy Update**

In order to take cognisance of the National Transport Strategy 2 and reflect on both the significant changes to the wider policy framework and the impacts of the pandemic on transport priorities within our region it is proposed that HITRANS officers commence a proportionate update of the Regional Transport Strategy. A number of other Regional Transport Partnerships are currently in the process of updating their Strategies.

Updating the strategy at this time also offers an opportunity for HITRANS to set out a potential role for the Partnership (building on the opportunities set out in recent reports presented to the Board) at a time when Transport Scotland has just begun a review of transport governance.

However, while some of the wider policy framework has developed since HITRANS last consulted through its Main Issues Report and draft RTS, it is felt that there is not a need to undertake a repeat public consultation on the strategic transport priorities of the area given the comprehensive exercise undertaken by Transport Scotland in developing STPR2 just last year.

Rather, it is proposed that we initially develop an update of Regional Transport Strategy that includes the following elements:

- A review of the vision, high level and sub objectives
- A review of the draft delivery plan, STPR2 options and priorities within the context of local, regional and national policy changes since 2017.
- Set out a vision of what HITRANS can offer as a Regional Transport Partnership within the context of a national review of transport governance.

This work would enable a draft updated Strategy to be developed which would then be published for public consultation prior to the submission of a final version to Scottish Ministers seeking their approval.

#### Recommendation

Members are invited to approve;

- That HITRANS officers further develop proposals for updating the Regional Transport Strategy in conjunction with Partnership Advisors as part of the Business Plan for 2021/22
- 2. Take a further report back to a future Partnership meeting setting out the more detail the scope and timetable to update the Regional Transport Strategy.
