EUROPEAN PROJECTS

Low carbon Travel and Transport Hubs (LCTT)

SUMMARY:

To provide Members with an update on round 2 of ERDF Low Carbon Travel and Transport funding awards.

LCTT Round 2 funding announcement:

On 8th August 2018, Michael Matheson, Cabinet secretary for Transport Infrastructure and Connectivity announced that 9 projects across Scotland were awarded funding worth £3.67M from European Regional Development Funds (ERDF) with an additional £1.65M from Transport Scotland.

An overview of the 9 projects which have been awarded funds are provided below:

At present, final details regarding the amount of funding agreed for each successful project has not been announced.

There are ongoing discussions between Highland and Transport Scotland regarding their Inverness Low Carbon and Active Travel Hub application, which it is hoped will also receive funding subject to resolution of the conditions which were attached to their grant offer letter.

It should be noted that Comhairle nan Eilean Siar were unsuccessful with their application.

With the potential for 3 successful projects, this amounts to £90,000 contribution between 2018/19 and 2019/20.
