PROGRAMME OF MEETINGS 2017

Purpose of Report

The report advises Members on the proposed dates for Partnership Board and Permanent Advisors meetings in 2017 and invites Members to indicate acceptance or changes to the dates. The proposal proposes a change in arrangement for the meetings in Inverness following discussion at the April 2016 Partnership Board Meeting.

Proposed Change to Meeting Approach

During discussion at the April 2016 Partnership Board meeting in Tarbert, Harris there was some discussion that reducing the costs of Partnership Board meetings should be investigated to identify opportunities to save budget within the 2016/17 Business Plan (under which item the discussion took place) and for future years. The past approach has seen HITRANS hold 2 meetings in partner Council areas apart from Highland. This has involved alternating each year between one of Argyll & Bute Council and Moray Council areas and alternating each year between Orkney Islands Council and Comhairle nan Eilean Siar. The remaining meetings have taken place in Highland (primarily in Inverness).

Until 2011/12 HITRANS held five Partnership meetings each year on the basis of a pre meeting on the Thursday afternoon/evening and main meeting on Friday morning but took the decision to reduce from five meetings per annum to four as a cost saving. This delivered a saving of approximately £1,500 per annum but posed a governance challenge that was resolved by reinstating a fifth meeting as a single day meeting aimed at Board Members only from June 2013. This maintained the majority of the cost saving but improved organisational accountability.

In considering potential budget savings around the Partnership Board meetings the Partnership Meeting Schedule follows and sets out a new approach with all the Highland area meetings becoming single day meetings with a pre meeting to take place in the morning 1030 to 1200 then lunch followed by a main meeting from 1300 to 1500. This will allow Members to travel to the meeting that day (with the exception of the Argyll and Bute Member and Advisor) and return that day. The saving for each meeting is estimated to be £1,500 and if the two Inverness located meetings that previously followed the Thursday afternoon/Friday morning schedule were to move to a single day session the total saving that could be moved to other budget lines would be £3.000.

Members are asked to consider this proposal although the opportunity to revert to the status quo or initiate this new approach on a single meeting basis is available.
