Minute of Meeting of 3 June 2011	1	The Minute of Meeting of 3 June 2011 was approved .	
Matters Arising	2	The Partnership Director indicated that discussions with key transport stakeholders had taken place to establish current transport issues in Caithness and the extent that they were not reflected in the Regional Transport Strategy. A Study into the provision of internal transport links in Caithness to support the renewable energy sector would be discussed at item 9 of the Agenda.

		FINANCE	
Revenue Budget Monitoring Report	3	The Partnership Treasurer submitted a Report detailing the revenue position for the period to 31 August 2012. The Report indicated that income and expenditure was broadly in line with the budget out-turn target and officers were not aware of any anomolies that would distort the overall financial position.	

It was agreed to note the Report.

HITRANS 2010/11 4 The Partnership Treasurer introduced Audit Scotland's Report, "The Audit of the Financial Statements and Governance Performance within HITRANS". The audit had concluded with an unqualified opinion being issued on the Financial Statements for 2010/11 and found that a sound corporate governance framework, commensurate with the size of the Partnership had been adopted.

RESEARCH AND STRATEGY DELIVERY

Travel Disruption Information System (Road) 5 Mr Ranald Robertson submitted a Report detailing progress made in delivering the Travel Disruption Information System Project. The Project sought to provide real time information on traffic conditions which would be relayed to the public as well as officers managing the network and this data could be used to modify traffic signal timings to maximise capacity and reduce delays to public transport by giving priority to late running vehicles. The Report detailed the locations under consideration for the siting of live eye cameras within the Highland Council area and other Authorities within the HITRANS area could utilise the web portal to facilitate the viewing of live eye CCTV camera travel alerts on roads within their areas.

> It was agreed to approve the allocation of £40,000 from the Research and Development Budget to support the development by The Highland Council of the Travel Highland web portal with live eye cameras at locations in Highland, Moray and other Council areas, if appropriate locations can be identified, and match funding agreed by other partner Authorities.

Research and 6 The Partnership Director submitted a Report in relation to the Research and Development Update 2011/12 The Report sought approval of amendments to the Programme to reflect commitments made and changes in priorities as funding opportunities were identified. The revisions sought to focus expenditure on actions that supported the Scottish Government and Local Authorities in delivering the Scottish Government's overall purpose of sustainable economic growth by supporting transport improvements across the HITRANS area that would deliver the Regional Transport Strategy.

Arising from this item, Members considered the potential detrimental economic impact of the withdrawal of the Air Discount Scheme for business travel.

It was agreed:

- (1) to approve the amendment to the Research/Strategy Development Programme 2011/12 as detailed in the Appendix to the Report.
- (2) that HITRANS, in conjunction with partner Authorities, would make representations to the Scottish Government seeking the retention of business travel under ADS, and;
- Value of Community Transport Analysis 7 Mr Ranald Robertson submitted a Report detailing the findings of the Value of Community Transport Economic Analysis work which was undertaken on behalf of HITRANS by DHC and TAS Partnership. The Study sought to quantify the benefits that community transport brought to different sectors and aimed to identify the social benefits, both financial and non-financial, of a small sample of Community Transport Projects in the HITRANS area. The Report summarised the key findings within the Study.

It was agreed to:

- (1) note the Report and;
- (2) issue a press release to publicise the findings in the Study.

Snowcamdubh 8 Mr Frank Roach submitted a Report in relation to the Snowcamdubh System which sought to provide Network Rail Staff with information on rail conditions during periods of extreme weather. The proposal would see the installation of cameras along Network Rail routes and would help provide information to enable Network Rail to decide whether to allow trains, close routes or deploy snow ploughs, thus providing greater reliability and surety of service for rail passengers.

It was agreed to note the Report.

	Report stated that the Study would look in particular at the impacts on the renewable energy and energy generation sectors and the decommissioning of Dounreay.
	It was to agreed to proceed with the Study.
Bus Route 10 Development	Mr Ranald Robertson submitted a Report detailing progress made delivering the Kick Start Bus Route Development Project to upgrade the Scottish Citylink bus service from Campbeltown to Glasgow. The Report stated that the Project had delivered improvements in terms of service frequency and vehicle quality with the number of journeys during the Summer season increased from three to five covering the whole route with an additional late afternoon journey between Glasgow and Ardrishaig. The Report highlighted the impacts in terms of passenger growth which had been recorded for the early Summer period.
	It was agreed to note the Report.
UK Aviation Scoping 11 Consultation and Peripheral Regions Input	The Partnership Director submitted a Report providing an update in relation to the UK Government's Aviation Strategy Scoping Consultation. The Report provided an update on discussions between peripheral regions of the UK containing a regional airport, and indicated that HITRANS and NESTRANS had been discussing common issues. Both Regions were concerned that the impact of the framework which would be developed following the Consultation could be significant for their areas and it would be important to emphasise in the strongest possible terms to the UK Government the economic importance for peripheral regions of good access to London and connectivity through the hub airports at Heathrow and Gatwick to the rest of the world.
	It was agreed to:
	 approve the proposal to participate in any Peripheral Regions Group with a view to a common approach by the Peripheral Regions in their responses to the UK Governments Aviation Strategy Consultation process;
	(2) approve the HITRANS response to the Consultation taking on board the views expressed by members, and agree to submit this by the due date of 17 October 2011, and;
	(3) authorise the Partnership Director to take such actions as necessary, including partnership working with other Regional Transport Partnerships, to ensure that the needs of the North of Scotland were reflected within proposal for high speed rail links.
Active Travel Audits 12 Up-date	Mr Frank Roach submitted a Report providing an update on the Active Travel Audit Programme. The Report stated that each Audit had produced a master plan for increasing the level of cycling and walking together with standard mapping that had assisted in procuring funds for specific Projects including Kirkwall Smarter Choices Smarter Places (£1.5 million), Elgin Urban Freedom (£1 million) and Highland Green and Active Travel (£500k).
	It was agreed to note the Report.
DRT/BSOG 13 Consultation	The Partnership Director submitted a Report detailing a proposed response to the Scottish Government's consultation exercise on extending Local Bus Registration and Bus Service Operator's Grant to Demand Responsive Transport. As the deadline for receipt of the response had occurred before the date of the Meeting the Partnership Director, in consultation with the Permanent Advisors, had submitted a response on behalf of the Partnership.
	It was agreed to homologate the actions of the Partnership Director in submitting HITRANS response as detailed in the Appendix to the Report.

START Update	Project	14	Mr Ranald Robertson submitted a Report detailing progress with delivery START Project actions within the Highlands and Islands. The Report stated that in addition to the budget secured from ERDF, HITRANS had allocated £25k from the Research and Development Budget to support activities that matched the START Project criteria and this funding had allowed a number of new schemes to be introduced which would deliver real benefits to passengers.

			(2) that HITRANS would be represented at the START Project Transnational Forum by the Chair, Mr Donald Manford, the Partnership Director and Partnership Manager.
Giant Puffir	u Update	15	Mr Frank Roach submitted a Report providing an update on the web based Giant Puffin Itinerary/Journey Planning Project. The Report stated that Steer Davies Gleave had been appointed to carry out the technical development of the website and it was planned to launch the website in February 2011 with a high profile marketing campaign.

Food Port F	Project	16	Mr Ranald Robertson submitted a Report in relation to the Food Port Project. The Report stated that the Project aimed to develop the North Sea region as the best food cluster and hub in Europe for food products delivered via efficient and sustainable transport systems, HITRANS had been alerted that a partner in the Project had withdrawn and their budget was being made available for new UK partners.
