Report to Partnership Meeting 17 September 2021 Consultation

Transport (Scotland) Act – Bus Services Consultation

Purpose of Report

This report invites Members to consider HITRANS response to the consultation on Implementing the new Bus Provisions in Part 3 of the Transport (Scotland) Act 2019

Background

Bus Services account for three quarters of all public transport journeys. However, bus patronage in Scotland (and the UK) has been declining since the 1960s with the trend continuing through and beyond the privatisation of the sector following deregulation in 1985. Set against this backdrop, the Transport (Scotland) Act 2019 has developed and refined the regulatory landscape with a suite of options designed to halt the decline in patronage and improve bus services.

Transport Scotland are now consulting with a view to informing the design of the implementation framework set out by the bus provisions contained within the 2019 Act, which covers partnership working, local services franchising, powers for local transport authorities to run their own buses and improvements to information.

The consultation contains questions on:

- Local Authority run services (questions 1 2)
- Bus Service Improvement Partnerships (questions 3 19)
- Local Services Franchises (questions 20 25)
- Information relating to services (guestions 26 34)
- Impact assessments (questions 35 36)

HITRANS officers have already begun to prepare a response to the consultation and are working with public transport managers in partner Local Authorities to help inform this submission. The deadline for submitting responses is 6th October. A verbal update of the key issues will be provided at the Partnership meeting with Members encouraged to highlight any key areas that the HITRANS response should focus on. A copy of HITRANS draft response will then be electronically shared with Members for comment and subsequent approval before it is formally submitted.
