MaaS Project Status Update

PURPOSE OF REPORT

To provide Board Members and Advisors with an update on the HITRANS (Mobility as a service) MaaS Project.

Background

Following securing of MaaS Investment Fund support in December 2019 the HITRANS MaaS project is now underway. The HITRANS MaaS Solution is called GO-HI and was launched at MVP (Minimum Viable Product) stage on 21 June 2021.

GO-HI is a Regional, multi-modal journey planning system using real-time data that offers account-based payment available to all users for all participating mobility options. The funding obtained was intended for an initial 6-month live pilot project but through internal virement of budget and additional funding from the Stronger Combined North Sea Region Project it has been possible to launch the platform for a 24 month period at the end of which time it is hoped that the platform will become sustainable based on use.

In addition to the platform the partnership with our INTERREG North Sea Region project, 'Stronger Combined' is also enabling the introduction of the Inverness eBike Dock System and MaaS programme marketing. A combination of Stronger Combined and Smarter Choices Smarter Places funding has enabled the appointment of a project officer to deliver the work.

GOHI project partner Enterprise Car Club have also increased the availability of car club vehicles including at new locations in Scrabster, Fort William, Aviemore, Kyle of Lochalsh and Portree.

HITRANS MaaS Project

The MaaS project is now well underway and until close of July 2021 has been tracking consistently against the previously reported COVID adjusted milestone dates.

The pilot project is planned to run for a total period of 24 months, and will deliver a new unified MaaS platform (website and app) with a range of functions including journey planning, booking and payment for public transport services. A summary of project status is presented herein with respect to each of the three workstreams:

- Research and Evaluation
- Marketing
- Technical

Project Status - Research & Evaluation

ITS, The Institute for Transport Studies, is leading the sub-group responsible for Research and Evaluation which includes the following partners: HITRANS, Enterprise, Arcadis, Shotl and Fleetondemand.

Positive feedback has been received from Transport Scotland on the submitted monitoring and evaluation programme deliverables. The background survey is complete and the next phase of evaluation activity is underway.

Project Status – Technical

Fleetondemand, as developer of 'Mobilleo' the main application platform, is leading the subgroup responsible for Technical delivery which includes the following partners: HITRANS, Enterprise, Arcadis, Skedgo, Shotl and IBI.

At MVP stage the platform launched with product sales available for rail, air, Car Club, bike club, Moray DRT and Stagecoach bus services.

Integration continues to progress well with further confirmed onboards for the pilot project of smaller bus operators via an app called Passenger 'MyTrip', West Coast Motors, Bewegen, and Northlink Ferries. The Northlink Ferries integration is presently sitting with Serco who need to give final corporate approval before go.

Discussion continue with other operators and Transport Scotland and it is hoped to bring other ferry operators on board.

The scalable nature of the GO-Hi technical solution enables additional services to be introduced throughout the pilot into 2023, resulting in increased coverage and transport options and thus providing service for a wider demographic of the Highlands and Islands community and its visitors.

This includes the addition of other transport modes such as ferry and on demand services, which play an important role for travel in the region, and new modes such as electric vehicles (EVs), and connected and autonomous vehicles (CAVs), which will be introduced to the region.

MaaS Investment Fund Round 2

The round 2 funding will allow the following additional features to be developed:

- GO-HI Platform provided by Fleetondemand's Mobilleo infrastructure will be developed for ITSO integration and additional service onboarding.
- Moray DRT system provided by Shotl is extended by a further 12 months.
- Car Club 16 vehicles will be available through Enterprise Car Club including four new electric cars.
- Evaluation of the platform by the Institute of Transport Studies at Leeds University
- Working with Proxismart an integration of their Travelperx incentivisation and rewards package will be developed.
- ITSO Smart Card Integration procurement required for the ITSO side and development of GO-HI platform for this integration.
- Full integration of ScotRail if they update digital services and CalMac if they can provide an API from their new booking system.
- Extended bike / eBike Share funded through the eHubs project which will also support at least 2 eHubs.
- Further DRT integration (rural and island solution) being tendered by HITRANS.

The first key new deliverable will be the DRT system which is out to tender with a closing date of 25th October. The estimated go live of this system will be early 2022. Tender evaluation is ongoing.

The PAV autonomous vehicle pilot at Inverness Campus has also been tendered with Evaluation and tender award being taken forward by officers.

Proxismant have contacted BID Managers with a view to working with them to introduce TravelPerx rewards. HITRANS has applied to the SCSP Open Fund for additional budget to extend coverage of this activity beyond Inverness and Elgin.

Budget

As lead partner the Mass Investment Fund budget is channeled to HITRANS to distribute across the Partnership in line with the detail of the application.

The total grant secured from MaaS Investment Fund Round 1 is £445,170.

The total grant secured from MaaS Investment Fund Round 2 is £408,772.

In addition to the contribution from MaaS Investment Fund HITRANS will be delivering a range of complementary measures from EU projects (Stronger Combined, eHubs, MOVE, ERDF Smart Mobility, FASTER and G-PaTRA) with a value of approximately £2Million.

The project management costs have been financed through Stronger Combined and a successful application submitted to the Smarter Choices Smarter Places Open Fund which is administered by Paths for All on behalf of Transport Scotland.
