## ACTIVE TRAVEL UPDATE

## **Purpose of Report**

This Report provides Board Members with an update on Active Travel projects in which HITRANS are currently involved.

## **REGIONAL ACTIVE TRAVEL BUDGET (Transport Scotland)**

2022-23 projects are well underway or complete and some highlights are given below:

#### Transport Integration

• The Citylink Website now allows travellers to reserve a space for their bike.

## Active Travel Masterplan Delivery

Construction of a new segregated cycle route in Campbeltown is underway. A storage container has been purchased for Moray Bothy, to give the Bothy a physical base in Cooper Park, Elgin. The Bothy will open officially in February.

#### Quiet Routes

The pilot is underway at 5 locations in Highland; 4 of these will be taken forward as Quiet Routes in Spring 2023 and the unsuitability of



the fifth as a Quiet Route will help to inform the development of future routes.

#### Mobility Hubs

New eBikes and docks added to the HI-BIKE system in Inverness; cycle parking will be delivered in Drumnadrochit and Kinmylies early 2023.

#### Active Travel Project Design

Designs underway for paths in North Islay and developing the initial proposals identified in the Tarbert Town Active Travel Study. Also some of the minor improvements recommended in the Fort William Active Travel Masterplan.

For 2023/24 financial year HTRANS has submitted a bid to Transport Scotland for £1.1M to include the following programmes:

2.	Transport Integration Better integrate cycling with bus travel by enabling bikes to be carried within buses on routes in Moray and Highland.	£100,000
3.	Active Travel Network & Strategy Development Support the development of connected active travel networks in Highland & the Western Isles.	£150,000
4.	AT Masterplans & 20 Min Communities Support the development of 20 Minute Communities in Moray, Highland and Wester Isles, by funding active travel masterplans and placemaking interventions in key settlements.	£150,000
5.	Quiet Routes & NCN Develop Quiet Routes as an integral part of connected active travel networks, by supporting delivery of 5 pilot routes and mapping Quiet Route networks in each of our partner Local Authorities.	£150,000
6.	Path Improvement Improve accessibility of existing active travel routes, by funding small scale interventions and mapping.	£125,000
7.	Resource Support Increase capacity within HITRANS to deliver projects with increased active travel budgets and support partner Local Authorities, by increasing staff resource. This will support the eHUBS Project Officer and an additional Business Support Assistant.	£80,000
8.	Monitoring Replacing the Sustrans Partnership Fund, this will support installation of multi-modal counters at strategic locations to establish baseline data across Highland region and the Western Isles.	£100,000

Transport Scotland has announced an additional Active Travel Transformation Fund for 2023/24, which is available to Local Authorities for delivery of projects ready for construction. HITRANS has encouraged and supported our partner Local Authorities to apply to this fund for capital works.

## SUSTRANS PARTNERSHIP FUNDING

Most projects under this fund are now complete, and partners are just waiting for the installation of the multi modal counters for which funding has been agreed.

Completed projects are:

- 20 Minute Community baseline mapping tool now available via HITRANS website
- Active Travel Masterplans for the Outer Hebrides
- Ullapool Sustainable Transport Plan
- Multi-modal counters in Nairn, Fort William, Stornoway, and Orkney.

The Sustrans Partnership will not continue in 2023/24 and the monitoring projects we would have funded through this have been incorporated into our bid to Transport Scotland.

## **OTHER PROJECTS**

#### HI-BIKE INVERNESS

Oversight of the electric bike share scheme has been passed on to Chris Finlay, our new eHUBS project officer, who will manage the future development of the scheme.

The new stations installed at Culloden, Hilton and Kinmylies have been well used, with the Hilton dock now the third most used after the Railway Station & Campus.
