RESEARCH AND STRATEGY DELIVERY

Research/Strategy Development Programme for 2024/25

SUMMARY

This Report provides the Partnership Board with an update on progress on delivering the Research and Strategy Development programme and seeks approval of amendments to the programme to reflect commitments made and changing priorities and funding opportunities identified since approval of the 2024/25 Business Plan at the Partnership meeting on 26th April 2024.

DETAIL

The Partnership at its meeting of 26th April agreed the HITRANS Business Plan for 2024/25 which includes a programme for Research and Strategy Development for 2024/25 in support of development, implementation and delivery of the HITRANS Regional Transport Strategy.

Work is progressing on delivery of the Programme as indicated in the Appendix to the report.

The Programme has been amended to reflect changes that have been identified to the circumstances surrounding some projects. The changes are summarised below and more information is provided on each change in Appendix A to this report.

Summary of key Programme changes:

- Reduce EU Funding Bid Support from £15,000 to £10,00 reflecting actual spend.
- Increase Regionally Significant Scheme Development from £40,000 to £55,000 to include the £15,000 cost for supporting the Health Transport Access Plan development and Western Isles Access to Health work which has separately been reported to recent Partnership Board meetings.
- Reduce budget for Inverness Station Masterplan from £35,000 to £20,000 to reflect more accurately the latest estimate of spend in 2024/25 for this work whose costs are committed to rise to £40,000 overall.
